Sirs MASTERS, SHIPOWNERS AND RESIDENT AGENTS FISHING VESSEL OF INTERNATIONAL SERVICE In your Office

Dear Sirs:

I take the opportunity to greet you and at the same time inform you that based on the recommendations issued by the Regional Fisheries Management Organizations (RFMOs), in particular about the delivery of previous transshipment notification, we inform you that we have proceeded to modify item 1 of the Appendix included in the Note DGIVC/0190/2019 dated February 21, 2019 and disclosed to all of you at the end of February of the same year, related to the use of templates by RFMO, since it will be necessary to receive notifications within a period of no less than 48 hours before the beginning of the transshipment.

It should be recalled that during the meetings held virtually on August 7 and 14, 2020, with the legal representatives of Panama flag international service fishing vessels, in relation to follow-up on compliance issues with RFMO and ARAP, such change had been announced.

In virtue of the above, the Authority request to Masters, Shipowners and Resident Agents, that the vessels provide the previous transshipment notification, to RFMOs and this Authority, within a period of no less than 48 hours before performing the activity and in turn, we reiterate that you should provide the transshipment report in a period of no more than 48 hours after the transshipment has occurred.

We appreciate your cooperation in order to comply with the information required by this entity and different Regional Organizations.
