Subjet:	International Capture Fishing Licenses and activities related to fishing to national flag vessels of international service.		
Ref.:	Executive Decree No. 131 of April 14, 2020		

Through Executive Decree No. 131 of April 14, 2020, international capture fishing licenses and activities related to fishing are established and regulated for vessels of national flag of international service, dictates provisions to prevent, discourage and eliminate, the illegal, unreported, unregulated fishing (INDNR) and establishes the financial contributions that fishing vessels must cover for their participation when they are registered in an RFMO of which the Republic of Panama is a Contracting Party or Cooperating Party not a Contracting Party; consequently, the rates based on the new Decree are:
